

#### Nominations

Nominations for the Section of General Practice's representative council will be accepted until Monday, Oct. 17.

Section of General Practice Representative Council nomination form *Voting* 

Voting will run from Monday, Oct. 24 to Monday, Nov. 14.

#### Vacancies

The electoral districts within the Section of General Practice are based on the former district health authorities. There is one vacancy in each of the following districts:

### Voting Eligibility

Members of the Section of General Practice may only nominate physicians from their own district, and may only vote within their own district.

### Honorarium and Travel

Council members receive a \$500 honorarium for each meeting and are reimbursed for travel expenses. Physicians have the option to connect to meetings via video-conference. The Council meets about four times a year, usually on Saturday mornings.

The Section of General Practice representative council advocates for the interests of family and practitioners. The council's work involves developing strategies for dealing with key issues affecting the role, responsibilities, and capabilities of general and family practitioners.



their patients affected by opioid use disorder? Buprenorphine/naloxone (BPN) is a long-acting opioid medication approved for use in opioid use disorder that can be prescribed to help manage the symptoms of opioid withdrawal in this population as a critical part of comprehensive addiction treatment.

No exemption is required from Health Canada to prescribe this medication. For providers unfamiliar with how or when to prescribe it the College of Physicians and Surgeons of NS recommends that providers consult with a colleague experienced in prescribing the medication and consider reviewing the CAMH Clinical Practice Guidelines. Currently, there is NS Pharmacare coverage for patients aged 18-24; however we are hoping that this coverage will be extended to all ages in the foreseeable future.

# my Wireless Headache Interventions

### Asking for your help- Self-guided interventions for migraine

I, Dr. Cathy MacLean, Professor in the Discipline of Family Medicine at Memorial University along with a multidisciplinary research team lead by Dr. Anna Huguet, a research scientist based at the IWK Health Centre, are working towards integrating cognitive behavioral therapy (CBT), which is an evidence-based treatment, for migraine headaches into primary care and neurology clinics across Atlantic Canada. To achieve this goal we have developed and conducted preliminary tests on two Internet-based self-guided CBT interventions for adolescents and adults with migraines. These interventions have the potential to empower

individuals to better manage their headaches by providing them with educational information and teaching them coping skills. Our next step is to test the effectiveness and cost-effectiveness of these interventions in primary care and neurology clinics. We are applying for research funding in the fall to support this project. In preparation for this grant application, we are asking physicians to consider recommending these interventions to their patients and encouraging them to participate in this study. We believe that these interventions can help reduce the frequency and severity of their migraines and reduce the negative impact that their headaches
